## **BYLAW 2022-008**

BEING a Bylaw of Vulcan County in the Province of Alberta to establish the time for payment of taxes and to impose penalties if taxes remain unpaid by the dates set out in the bylaw.

WHEREAS pursuant to Section 344(1), Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, and amendments thereto, a Council may by Bylaw impose penalties in the year in which a tax is imposed if the tax remains unpaid after the date shown on the tax notice;

AND WHEREAS pursuant to Section 345(1) Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, and amendments thereto, a Council may by Bylaw impose penalties in any year following the year in which a tax is imposed if the tax remains unpaid after December 31 of the year in which it was imposed;

AND WHEREAS the Council of Vulcan County deems it appropriate to establish the time for payment of taxes and to provide for penalties on unpaid taxes;

NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council of Vulcan County in the Province of Alberta, duly assembled does hereby enact as follows:

- 1. That the current tax levy in any year shall be due and payable in full on July 31st in the year in which they are levied.
- 2. That a penalty or penalties shall be imposed on current taxes or any portion thereof remaining unpaid after the due date as follows:

| a) On August 1st or 30 days from the date of mailing of the Tax | Six percent (6%) penalty   |

| b) On October 1st   | Three percent (3%) penalty |
| c) On December 1st  | Three percent (3%) penalty |

Any penalties imposed within 30 days of the mailing of the Tax Notices shall be waived.
